
Are you aware of the \$55m that our government has invested in the media to control them and their reporting?

Dear people

Following the second world war the Nuremberg Trials were set up to prosecute people who knowingly, deliberately, and wilfully engaged in criminal activities by carrying out medical experiments, or ordering people to carry out medical experiments on people who could not give informed consent and where the excuse that, I was only carrying out orders was not deemed to be an excuse. In fact these people were so confident that they never considered that there would be ramifications for their actions. Following conviction the guilty were taken to a compound, blindfolded, tied to a solid post, and executed by firing squad.

The people executed for these war crimes were people who had been involved in medical experiments where the person receiving the experimental medication had no option to give informed consent.

The Pfizer biotech medication is an experimental medication, such as those experimental medications that were given to people by German authorities in the second World War. The period for trials of the experimental Pfizer biotech medication will not end until May 2023.

It has not been disclosed by the New Zealand government what the ingredients of the Pfizer biotech medication are, therefore it follows that no person in New Zealand being directed to take the experimental Pfizer biotech medication by the New Zealand government can give informed consent, because the information required for adequate informed consent has not been provided by the New Zealand government.

Pfizer has been convicted of criminality in US Courts for health care fraud. Pfizer has been a habitual offender, persistently engaging in illegal and corrupt marketing practices, bribing physicians and suppressing adverse trial results. Since 2002 the company and its subsidiaries have been assessed \$3 billion in criminal convictions, civil penalties and jury awards. The \$2.3-billion settlement in September 2009 after Pfizer was ordered to Pay \$2.3 Billion for Fraudulent Marketing set a new record for both criminal fines and total penalties. Other Pfizer medications that have attracted lawsuits include Prempro, Protonix, Depo-Testosterone, Zoloft, Effexor., Chantix. Marketed as Chantix in the United States of America this drug is known as Champix in New Zealand and the New Zealand government allows this medication to be advertised freely and including television advertisements. Chantix/Champix is at the top of the list of the top 10 prescribed medications known to cause suicide and violence in the people who have been prescribed these medications.

This criminality is public knowledge and therefore the New Zealand government is knowingly and actively involved with a criminal organisation. Moreover the New Zealand government is actively promoting experimental medications manufactured by a company known to be a criminal organisation.

The New Zealand government is knowingly and actively promoting a medication that they know is an experimental medication produced by a company convicted of criminal behaviour.

The New Zealand government is knowingly and actively promoting a medication that they know is an experimental medication produced by a company convicted of criminal behaviour without the recipients of that experimental medication having any knowledge of what products are in the experimental medication or the harms that might be caused by the experimental medication immediately post injection and in the long term and who therefore cannot give informed consent.

The New Zealand government is knowingly and by deception promoting an experimental biotech medication, as a vaccine.

Having phoney lockdowns based on spurious pretexts to force New Zealand citizens to get injected with an experimental biotech medication exposes more of the criminality.

The demonstrable lack of effectiveness of the Pfizer biotech injection is such that Israel who began using the Pfizer biotech medication in December 2020 is now talking about requiring its citizens to get their 4th shot. Of the patients in Israel hospitalised with COVID-19 as of August 15 2021, 59% were fully vaccinated according to an August 16 article from Science. Israel has one of the world's highest COVID-19 vaccination levels, with about 78 percent of those aged 12 and older fully vaccinated, mostly with the Pfizer vaccine which was made for when the virus first appeared and which has now mutated over four more editions rendering the current biotech medication obsolete referenced by the number of hospitalisations worldwide for people who have been fully vaccinated .

Encouraging New Zealand employers to blackmail employees to have an experimental biotech medication injected into their bodies where the short term adverse events are known to be detrimental to people and where the long term adverse events are not known because the trials for the experimental biotech medication have not reached a conclusion, by stating to their employees that they will have no job no jab-no job if they do not allow an experimental medication to be injected into their bodies also without supplying information as to what products are in the experimental medication so that their employees can make informed consent also exposes more of the criminality.

The inventor of the mRNA technology Robert Malone has spoken out against using this technology. Michael Yeadon a former scientific researcher and vice president at Pfizer has spoken out against using the Pfizer medication. Many doctors around the world have spoken out against the use of mRNA technology among them the highly credentialed and highly esteemed Dr Peter McCullough https://rumble.com/vnbv86-winning-the-war-against-therapeutic-nihilism-and-trusted-treatments-vs-unte.html . To ignore what these learned people are saying about the harms being produced by the experimental biotech medication further exposes criminality.

Easily produced off licence oral medications used as prophylactics against getting Covid-19 or for at-home treatment for the effective treatment of Covid-19 have been banned for use by the New Zealand government even with a lot of evidence that these safe medications are extremely

effective in the prevention and treatment of Covid-19 and instead promoting the injecting of an experimental biotech medication of which it is common knowledge that this drug causes deaths and many adverse reactions in people who have been injected with it further exposes more of the criminality. I understand that the New Zealand government has dug Itself into a hole with their course of actions that they have embarked on with regard to coercing New Zealand citizens to get injected with an experimental biotech medication and that it is politically dangerous to alter course, but the New Zealand government cannot keep causing harm to New Zealand citizens to further their political ambitions. This course of action is not only selfish, it is criminal. The Nuremberg Trials at the end of the Second World War created the Nuremberg Code which forbade any government or anyone from conducting trials on people involving experimental medications. Just how serious this was considered to be was demonstrated by the firing squad executions following legal trials for these offences. The day of reckoning is coming. I therefore submit that the New Zealand government abandon the Covid-19 Public Health Response Amendment Bill (No. 2), abandon altogether the current approach with coercing New Zealanders to be injected with an experimental biotech medication known to cause death and other adverse events and adopt an approach to preventing and treating Covid-19 using a wellness model that will allow New Zealanders to resume a normal life free of coercion, lockdowns, and restrictions the way we do for other serious maladies such as seasonal influenza, bronchitis. pneumonia that are statistically far worse than Covid-19.
